Activations:

NFL Draft in Detroit was a huge planning success. Detroit did a great job with resource allocation and operations. MABAS had Deployment Coordinators at Huntington Place with DFD Operations and Oakland County IMT. MABAS deployed 75 radios that were used by EMS personnel. One After Action lesson learned was using these Pre Planned events to establish Points of Contacts for Out of Division box cards. MABAS established POC for Macomb, Western Wayne, Washtenaw and Livingston divisions which resulted in updates to response plans. We will look to continue this practice with Fire Ops Chief Pat Parker and Special Ops Chief Chris Martin contacting Division Plans Coordinators and Special Ops Team Leaders respectively. MI-TF1 Deployed a 17 member Type I Swiftwater Team to Texas Floods on May 3rd through an EMAC request for a 7 day deployment. They arrived in Bryan, TX on 5/4 and are stationed with NC-1. All of our swiftwater training along with our GPS and SARCOP training is being utilized. More info to follow.
