5. Special Operations Director – McIntyre:
 - a. Work Plan Update: Met with Haggerty Consulting regarding uploading MRPs into EMAC System. Very good meeting to understand the three software programs will NEVER be in synch. Main message to EMHSD is these are good estimates. We would need to build the roster before submitting our MRP to EMAC. Two most important factors are speed and relationships. We have a meeting with EMHSD on 4/23. Helpful if we are state SAR alternate coordinator.
6. Training & Exercise Chief – Whitehead:
 - a. Work Plan Update: MABAS awareness training through Safe Response project is on hold. We are looking for an alternative virtual learning platform. Let us know if you have any suggestions. Two day UAS orientation is now and will be implemented at ORE, mapping and tracking. We will develop a future MRP.
 - b. Had members participate in or are participating in Med Spec in FL, Advance shoring in TX, RBO in VA and GPS awareness local trainings.
7. Special Operations Chief – Martin
 - a. Work Plan Update: Will create type III Water Rescue validation process, Plainfield Twp drone validation upcoming, Macomb Tech will validate this summer, Livingston and Washtenaw County hazmat team validation is TBD. 42,000 ERG guide books at MOB Center.
8. IMT/IST Coordinator – Evans
 - a. Work Plan Update: UAS information will be incorporated into SARCOP program with quick capture. Updating MRP process
9. Old Business
 - a. MRP Handbook: MRP Handbook draft will be formalized Resource guide
 - b. FY24 Grant Update: Compiling Q2 report for LARA. We have spent over 50% of the total grant.
 - c. Vermont Reimbursement: Received notice last Friday that we should expect payment within the next 1-2 weeks.
 - d. Service Vehicle (PU-9): Chassis delivered, sending to Knapenhide in 4-6 weeks.

 - b. KRC Training Building - Holly: Working with a demolition company to coordinate training scenarios. Inviting other validated tech rescue teams or leadership 6/8. Extensive shoring operations. MI-TF1
