**MI-TF1:** Type I Swiftwater is fully engaged with other FEMA, EMAC, State and Local resources operating on SARCOP. SC SAR Coordinator is Chad Beam who was in Michigan for HART program training in 2018. We still have a Type III USAR cache at the MOB but would be short one pick up. Not sure we can roster enough personnel. We have 92 deployable personnel at home but most of our Rescue Specialists are in SC.

**Budget Update:** Have approximately \$100,000 left in grant with the majority encumbered. We will definitely need to spend some of the contingency fund. Cannot receive FY25 money until FY24 year end report is complete. We will be able to submit our year end report early.

**Reimbursement:** Texas reimbursement was sent to EMHSD on 7/25. Total reimbursement is for \$269,553.20 with \$178,001.67 due to sponsoring agencies and \$91,551.53 due to MABAS. EMHSD had an initial request for bank statements but nothing since 7/26. Reimbursement is supposed to be within 90 days.
