MI-TF1: All equipment and personnel are returned to service from South Carolina deployment. Looking to stabilize the ride and load plans. Removed ILS trailer from Swiftwater MRP. Orientation is scheduled for October 22nd, applications being accepted. Notice will be posted on MABAS website.

South Carolina AAR was held with EMHSD on 8/19. They have asked for a deployment presentation at their divisional meeting in October.

Budget Update: When payroll is processed tomorrow we will have spent around 95% of FY24 appropriation with two payrolls and encumbered expenses still remaining. We are in good shape and placed a temporary hold on Backfill reimbursement until 10/1. We should be able to submit year end report around 10/1.

We will be proposing the same FY24 budget categories and amounts to the SOWG on 8/28 for FY25.

Contingency Fund has a current balance of \$550,000. We will also be proposing to SOWG to reimburse the local agencies who sent personnel to Texas at a cost of \$178,001. We will also need to spend \$35,000 for South Carolina deployment and \$50,000 for FY25 Appropriation seed money. This will leave an approximate Contingency Fund balance of \$287,000 for any FY24 deployment.

Reimbursement: Texas reimbursement is being reviewed by EMHSD. The total reimbursement is \$269,553. Deadline for EMHSD to submit to Texas is 9/15. South Carolina reimbursement has started. Locals have until 9/26 to submit and we have until 11/11 to submit to EMHSD. We are well ahead of schedule.
