Trying to get the conversations started again with Francis. He has been busy. He advised me that he is almost ready to pick a Supervisor so hopefully this will speed the process along for me. Add the phone number 517-715-4911 to your contacts. This will be the number from their RAVE system.



MI, WI, IL RED Center meetings: I met with the EM for the Badger Red Center. Their Supervisors are the only persons in the center to handle MABAS incidents. They normally have 6 Supervisors and 3 of them have left recently. Met two young ladies at the conference. We were discussing a MABAS incident and how they handled the process and neither of them knew it. They wanted to know it but it was a kept secret with the Supervisors. The next day, I was speaking to MABAS leaders, showing them our Google Sheet, and discussing the process. The next thing I knew, I was holding my own presentation in the hallway as the leaders kept growing. I have sent an email to the director of Badger Red to hopefully get monthly conversations started amongst the 3 RED centers again.

EMABAS / HIEBA Software:

I accepted a position as a sales representative for HIEBA back in April. Working on my retirement gig.

MI MABAS looked at the EMABAS software back in 9/2021. We were moving to bring this software to the RED center on a trial basis and the conversations went dark due to the owner's primary job and a new baby.

The owner sold the company to some investors who saw the potential currently used in WI by several counties. They spent a lot of money making improvements and updated the software with more features.

St Clair and Tuscola Counties are implementing the software in MI. Some of the key features of the software include:

- **Dynamic BOX Card Management**: Chiefs can adjust responses, with automated email notifications to the agencies. Unanswered changes are auto-approved after 30 days then they are available to the dispatch center. Less duplication of resources on a card.
- **Real-time Alerts**: The system sends alerts for BOX card activations for all the agencies due on the card giving personnel time to prepare or monitor the situation.
- Standardized Scripts: Provides consistent messaging across radio communications.
- **Comprehensive Tracking**: Logs times, status changes, and mayday policies for better incident management when compared to some CAD abilities for the fire service.

I have been discussing the software with Hillsdale, Shiawassee, Western Wayne, Washtenaw, and Muskegon so far.

Would like to discuss this at the Executive Board and Plans Coordinator meeting in hopes of performing a Demo for them to get this valuable tool in their agency and dispatch centers. 
