

EMHSD - Michelle Sosinski - the 'All Hazards IMT' certification guide is now fully available for use. However, budgets are decreased. Working with state training officers and other state agencies to leverage any funds possible. Dave McIntyre added that we (MABAS) will work with the state, if there is a high demand for a course then we could share the cost and host. We are all working together. Sosinkski will keep that in mind to maybe have 2-3 courses this year. She also mentioned that HAZMAT expansion is still expected to break ground this spring. Matt Cook EMAC - currently no one out the door on deployments. Biggest focus has been hurricane reimbursements and currently 8 reimbursements packets pending. February 4th, 2025 will be our quarterly internal advanced team staff exercise. Some Region 5 partners will join for a multi-state exercise sandbox event with WI, OH and MN.
