Minutes

- 1. Call to Order Pat Parker called the meeting to order at 1330 hours.
- Roll Call Gabie Keeling completed rollcall via Zoom.
- Welcome
- Approval of the December 11, 2024 Minutes Pat Parker approved the December minutes as presented by email.
- 5. Public Comment Shadd Whitehead expressed big kudos to Division 3702 on their recent ice storm with their hard work and response time. Mike Evans shared that power restoration is around 90% at this time. A State declaration has been signed and Michigan will be applying for a Presidential declaration to help with restoration and cleanup efforts. Doug Pratt thanked everyone for the assistance in the northern Michigan ice storm and the response went well. 3201 asked about the after action report for this incident. Shadd Whitehead stated that reimbursement would follow MEMA and MABAS but more to follow. He also noted that AARs would all be separate (from each agency, National Guard and power companies involved). Mike Cousins gave an update of the recent Chief's Conference.
- 6. Old Business Pat Parker gave a brief overview of the recent incidents in 2025 and expressed his appreciation to all the teams involved in all mutual aid efforts.
